By purchasing, accessing, or using Sassy Stickers LLC content, I agree to the following terms:

Usage & Restrictions

- 1. I will use Sassy Stickers LLC designs, templates, and graphics solely for my personal business use.
- 2. I will not share, sell, or distribute any designs with others, including other independent consultants, directors, or teams.
- 3. I will not claim ownership of or take credit for any Sassy Stickers LLC designs, concepts, or content.
- 4. I will not modify, recreate, or remove branding from any Sassy Stickers LLC products.
- 5. I will not provide access to Sassy Stickers LLC content to any graphic designer, virtual assistant, or third party for reproduction, resale, or commercial use.

Subscription & Access

- 1. Personal Use Only
 - a. My subscription grants personal use only and may not be shared with others.
- 2. Sharing with Personal Assistants
 - a. I may share my login credentials with a **personal assistant** who is directly assisting me with my business and helping me manage my team. The personal assistant may only access content for use **exclusively within my personal team** and **cannot** use Sassy Stickers LLC content for clients outside my team or business. If my assistant works with multiple consultants or clients, they are prohibited from using Sassy Stickers LLC content for any purpose other than assisting me and my team.
- 3. Prohibited Actions
 - a. I will not share my login credentials with any **graphic designer**, **virtual assistant**, **or third party** who is not assisting my personal business. Additionally, I will not download content for redistribution, provide access to anyone outside my personal unit, or attempt to circumvent the subscription by recreating or redistributing designs.

Printing & Distribution

• Both Freebie designs and Subscription only designs are for **print-only use** and may **not be downloaded, saved, or distributed digitally.**

Permitted Use for Printing and Distribution

1. Printing for Personal Use and Prizes

You are allowed to print sheets of stickers, postcards, or other Sassy Stickers LLC content for **personal use** or to **distribute as prizes** to consultants within your **personal team.** This includes using printed items as gifts or rewards for your team, but it does not extend to distributing digital files or using the content outside of your personal unit.

2. Sharing Printed Materials

You may share printed stickers, postcards, or designs with other consultants in your personal unit for use as prizes, incentives, or personal use. **Printed materials are not to be resold** or distributed outside your personal unit without explicit consent from Sassy Stickers LLC.

3. Prohibited Actions

Sharing **login credentials** and/or **downloading content to external devices** for redistribution is strictly prohibited. You may not distribute digital files or share access to your account for others to download or use the graphics. Any violations of this restriction will result in immediate removal of access to content and potential legal action.

Custom Work Ownership

- 1. Custom designs created by Sassy Stickers LLC are the property of the client once the **final invoice is paid in full**.
- 2. Upon payment, the client is granted full rights to **download**, **use**, **and print** the design for personal or business purposes.
- 3. Sassy Stickers LLC retains the right to showcase custom work in portfolios, marketing materials, or social media unless otherwise agreed upon in writing.
- 4. Custom work may **not** be resold, distributed, or used for commercial template creation.

Violations & Consequences

Failure to comply with these terms may result in immediate consequences, including but not limited to:

1. Monitoring and Tracking of Usage

Sassy Stickers LLC reserves the right to track and monitor activity related to downloads, printing, and usage of content to ensure compliance with these terms. This includes, but is not limited to, monitoring the frequency of downloads and printing behavior for indications of unauthorized sharing or redistribution.

2. Immediate Revocation of Access

If Sassy Stickers LLC detects any violation, including unauthorized downloading, redistribution of content, or misuse of login credentials, access to all content will be **immediately revoked** without refund or recourse.

3. Legal Action for Breach of Terms

Any violation of these terms, including but not limited to unauthorized distribution, sharing, reselling, downloading for others, or circumventing any part of the subscription program, will result in **legal action**. This may include claims for lost income, damages, attorney fees, and any other enforceable compensation. Violations are subject to full legal enforcement and prosecution to the fullest extent of the law.

Binding Arbitration
